#### 1. <u>BID AND CONTRACT DOCUMENTS (1 page)</u>:

1. Replace Page 28 of the Bid and Contract Documents with the attached revised Unit Price Bid Proposal for the Bid Alternatives (Attachment 1), which was revised to correct Bid Alternative 1 & 2 item numbers.

#### 2. CONSTRUCTION PLANS (1 Sheet)

• Replace the cover sheet of the plan set issued with Addendum 2 with the attached signed cover sheet (Attachment 2). The remainder of the plan set issued with Addendum 2 shall remain the same.

#### 3. <u>QUESTIONS FROM PROSPECTIVE BIDDERS</u>

- Q1: Is there a color requirement for the gravel mulch?
- A1: No
- **Q2:** The bid form for Alternate 1 is slightly confusing. You have Bid Items 19 and 20 for negative quantities, yet this refers to (#19) 6" Curb and (#20) 42" HDPE. I think the Alternate 1 bid form should have Bid Items 20 and 21 for negative quantities?
- A2: Page 28 of the Unit Price Bid Proposal was revised. See "BID AND CONTRACT DOCUMENTS" section above and Attachment 1.

#### 4. MISCELLANEOUS INFORMATION/CORRECTIONS:

- 1. **MINOR CORRECTION TO ADDENDUM 2:** Item 3 "Responses to Questions from Prospective Bidders Spreadsheet" under the "Attachments" section of Addendum 2 referred to 4 pages, but the attachment has 5 pages.
- 2. **FOR YOUR INFORMATION:** SSCAFCA encourages small and minority businesses, women's business enterprises, and labor surplus area firms to participate in this solicitation. See Attachment 3.

All other provisions of the Bid and Contract Documents shall remain unchanged. This Addendum is hereby made a part of the Bid and Contract Documents to the same extent as those provisions contained in the originals.
