ADDENDUM #2

This Addendum consists of two (2) pages and five (5) attachments. The information contained in this addendum shall be incorporated into the project bid and contract documents the same as if originally contained therein.

Bidders shall acknowledge receipt of this addendum on the Bid Proposal form in the space provided. Failure to acknowledge this addendum by any prospective bidder will render the bid non-responsive.

1. BID AND CONTRACT DOCUMENTS (5 pages)

- Replace Pages 23-28 of the Bid and Contract Documents with the attached revised Unit Price Bid Proposal (**Attachment 1**), which was revised to rectify and clarify some descriptions that were not consistent with the descriptions in the construction plans. Also, the Bid Alternate tables were revised to simplify the bid preparation and bid evaluation processes.

2. CONSTRUCTION PLANS (58 Sheets)

- Replace the entire plan set with the set dated October 2, 2019. Multiple clarifications were made throughout the plan set along with additional build notes and dimensions to assist in construction layout and estimating. Note that some items in the Schedule of Quantities have been combined and their descriptions clarified.
- The only design change made was the shifting the proposed 42" storm drain southward in 11th Avenue to increase the clearance from the existing 6" water line. The revised plans are **Attachment 2** to this Addendum and may be downloaded from the SSCAFCA Website.

3. RESPONSES TO QUESTIONS FROM PROSPECTIVE BIDDERS (4 pages)

- The attached spreadsheet (**Attachment 3**) lists questions received since the issuance of Addendum No. 1 and the issuance of this addendum and associated responses.

4. ACAD SURFACES & CONTOURS – EXISTING AND PROPOSED

- AutoCAD Civil3D xml file (**Attachment 4**) includes existing and proposed surfaces for use by prospective bidders in determining/verifying earthwork quantities.
 - AutoCAD dwg file (**Attachment 5**) contains 1' contours (as polylines) extracted from existing and proposed surfaces (xml file referenced above) for use by prospective bidders in determining/verifying earthwork quantities.
