# Main Project Components

- I. Approx. I 600-LF of trenching and backfill
  - I. Trench Depths approx. 15-20 feet
- 2. Reinforced Concrete Pipe 18" (40-lf), 36" (1240-lf), 42" (365-lf), and 48" (365-lf)
- 3. Five 8-ft diameter manholes
- 4. Storm Inlet Type C Single
- 5. SWPPP

# Comments from SSCAFCA

- City of Rio Rancho ROW Permit Obtain through Development Services - \$50 fee
  - Biggest concern is off-road traffic thru site (security)
  - CORR will provide construction observation
- Right-of-Way Considerations
  - All plan elements are within public ROW
  - If the Contractor wishes to utilize private property for any reason, they should contact the property owner(s) and get written permission
    - It is the Contractor's responsibility to have written permission prior to start of construction

- SSCAFCA and City Staff will be providing construction oversight on project
- Engineer's cost estimate: \$390,000
- SSCAFCA does not maintain a Bidder's List
