A motion was made by Director Ron Abramshe to approve the agenda. It was seconded by Director Michael Vidal and passed unanimously.

<u>ACTION/APPROVAL OF THE MINUTES OF THE REGULAR BOARD MEETING OF FEBRUARY 15, 2024</u>

A motion was made by Director Michael Vidal to approve the minutes of the Regular Board Meeting of February 15, 2024. It was seconded by Director Bel Marquez. The motion was passed unanimously.

1. Resolution 2024-07, Notice of Bond Sale, and Delegation of Authority

Mr. Gatterman introduced Mr. Art Melendes who is SSCAFCA Bond Counsel. Mr. Melendres indicated the Resolution in front of the board was to formally authorize formally the sale of \$6,000,000 of General Obligation Bonds.

2. Legislative Update by Larry Horan (Virtual)

Specifically, he stated that SSCAFCA requests for capital outlay funding were funded in the capital outlay bill with special note that the graduate student program we got funded last year through the Junior Spending Bill was now routed through a general appropriations bill labeled as a GRO Special Appropriation.

3. Action/Acceptance of on-call contracts with selected Environmental Consulting firms

Mr. Gatterman mentioned we received 10 proposals responding to our RFP for Environmental Consulting Firms and asked for acceptance of on-call contracts with the selected firms:

- Wilson & Company

A motion was made by Director Ron Abramshe to accept on-call contracts for Environmental Consulting with DB Stevens and Associates and Wilson and Company. It was seconded by Director Michael Vidal and passed unanimously.
